Please join us for the annual Sinclair Lewis Days Craft and Vendor Sale on Saturday, July 18, 2026. The craft fair is held at the Sinclair Lewis Park located off of Hwy. 71 and lures many passing through visitors. This is a great opportunity for vendors to sell their goods to a wide audience.

This is an “Open Air Show” and will be held RAIN OR SHINE. The area does include a roofed shelter which has room for 10 spaces. **Space reservations will go quickly, so please respond early if you desire to be in the shelter by mailing your registration form & payment for your space(s).** Some vendors ask for more than one space. **Booths assigned in order of postal date on registration envelope.**

LOCATION OF EVENT:

The Sinclair Lewis City Park is located on Main Street North (Hwy. 71) in downtown Sauk Centre.

DATE OF EVENT:

Saturday, July 18, 2026 from 9 A.M. to 3 P.M., This is a one-day event.

SET-UP TIME AND REGISTRATION:

Set-up of booths is Saturday July 18, 2026, 7:00-8:30a.m. Unfortunately, there’s no set-up of anything the day/night before the event because this area will be used for a city dance and fireworks display. Registrations will also be taken the day of the event.

COSTS:

Spaces will cost \$50.00 each, shelter spaces \$60.00 each. Make checks, payable to Sauk Centre Area History Museum & Research Center. The deadline for early registration is June 18th. SPACES RESERVED **AFTER JUNE 19th** WILL COST \$55.00 and \$65.00. **Regrettably, there are no refunds of paid spaces.**

SPACES:

Space size is approximately 11X11 ft. No tables or tents are provided. Please bring leveling blocks to stabilize your table(s) if necessary. Space #'s will be mailed to you by July 1st if you register early, otherwise the week of the event. If you would like to be in the shelter or have a desired space request, please register early. **Although it is impossible to guarantee a spot;** the earlier we know your preference, the better we can accommodate you. We do not have any tents or canvas shelters for use.

- Camping is available in the adjacent campground which includes a splash pad. Restrooms are located in the park. Please contact the City of Sauk Centre at 320-352-2203.
